This book examines the history of the Church's financial affairs, at universal and national level, as a background to understanding the formulation of the canons on temporal goods in the 1983 Code of Canon Law. Analysing the requirements of the charity legislation and comparing the response of each diocese demonstrates that, although the Church is quite clearly providing a great deal of 'public benefit' through its range of activities, the reporting of these suggests that the 'public benefit requirement' is still viewed as more of a threat rather than an opportunity.
